- > You have the right to lodge a complaint to the following Supervisory Authority: Guarantor for the personal data protection;
- In the processings whose legal basis is indicated as: fulfillment of a legal obligation or contract execution of which the interested party is involved, the communication of your personal data is necessary to process your request, therefore, in case of failure to communicate such data, we could not proceed with the related activities;
- Your data will not be subject to any automated decision process.
